6 EXECUTIVE SUMMARY

- 6.1 Council approved on 10 December 2003 the extension of the Wynberg City Improvement District operations to 31 December 2004.
- 6.2 Application, in terms of Section 11(4) of the CID By-Law is now made to Council for the further extension of the CID's term to 30 June 2007.
- 6.3 At the AGM of the Wynberg City Improvement District held on 30 June 2004, the members approved the Business Plan dated April 2004.

7 RECOMMENDATIONS

It is recommended that Council:

7.1 Approve the extension of the Wynberg City Improvement District term to 30 June 2007 in terms of Section 11(4) of the CID By-Law as per the Business Plan dated April 2004.

8 DISCUSSION/CONTENTS

- 8.1 The approval of the extension of the Wynberg City Improvement District by one year was required as the South Peninsula Municipal By-Law that was applicable, did not make provision for a full three year extension.
- 8.2 The uniform CID By-Law Section 18(3) requires that within one year of the operative date of the By-Law (1st of July 2004) all CIDs must take steps to amend their financial year in order to comply with the financial year of Council.

Section 18(4) further states that any City Improvement plan which terminates in the course of the City's financial year shall be deemed to have been extended to the end of the relevant financial year.

- 8.3 This resulted in the Wynberg City Improvement District's first year of its second term ending on 30 June 2005.
- 8.4 An application in terms of Section 11(4) of the CID By-Law has been made by the Management body of Wynberg City Improvement District to extend the CID's term.
- 8.5 A three year Business Plan dated April 2004 attached as Annexure A was submitted.
 - The Business Plan is a continuation of the operations of the original CID.
 - The annual increase by 10% of the Budget is also a continuation of the previous Business Plan provision.
- 8.6 At the AGM of the Wynberg City Improvement District held on 30 June 2004, the members approved the Business Plan dated April 2004.
- 8.7 As the Business Plan (April 2004) does not materially affect the rights or interests of any person nor does it affect the levy to be charged, Council could approve the application to extend the term of the Wynberg City Improvement District to 30 June 2007.

BUSINESS PLAN OUTLINE

This Business Plan is based on the operational experience gained by the Wynberg Improvement District since it's inception in October 2000.

- ➤ The initial three year plan was extended for a period of one year (1 July 2003 to 30 June 2004) as approved by the City of Cape Town.
- ➤ It is the intention of the Wynberg Improvement District to continue it's operation for a further three year period from 1 July 2004 based on the original agreements with adjustments to the budget as per the attached budget schedule (which is VAT exclusive).
- ➤ The boundaries of the Wynberg Improvement District remain unchanged. Consideration is to be given to the possibility of extending these boundaries during this continuation period (not included in the budget schedule).
- ➤ Acceptance by the members of this Business Plan and Budget to be obtained by 30 June 2004 and ratified at the upcoming AGM.

SERVICES AND LEVEL OF SERVICES TO CONTINUE TO BE PROVIDED BY THE WYNBERG IMPROVEMENT DISTRICT

The Wynberg Improvement District will continue operating as per the current term and in terms of it's Memorandum and Articles of Association registered as 'Wynberg Improvement District an incorporated association not for gain (in terms of Section 21 of the Companies Act)' with Board of Directors elected at it's AGM.

2 SAFETY AND SECURITY

These will continue as per the original Service Level Agreement with the City, as amended.

The Wynberg Improvement District provides a daytime 'top-up' security patrol undertaken by a private security company, Securicor (South Africa) (Pty) Limited, together with two contracted Community Police Officers.

The only change envisaged is that in respect of the CPO's who we understand will be falling away at the end of the current year.

3 CLEANING

The 'top-up' cleaning operation carried out by private contractor, Nu-Tech Cleaning and Hygiene Services, will continue as per the original Service Level Agreement with the City. Shifts have been adjusted to ensure litter is cleared before and after normal business hours.

4 MARKETING AND IMAGE

We will continue to promote the achievements of the WID in local community newspapers. The budget makes provision for regular newsletters for members.

5 SOCIAL

Vagrancy remains an ongoing issue and the Wynberg Improvement District is committed to supporting the Wynberg Street People Service Providers Forum and managing the numbers of street people through regular monitoring and assisting in assessment and repatriation.

WYNBERG IMPROVEMENT DISTRICT BUDGET

The budget figures for the financial years 2004/5, 2005/6 and 2006/7 are attached.

Crime and grime remain the priority areas and this is reflected in the budget allocations over the three year period.
